April 29-30, 2017, will be the Cornhusker Pony Club's Shaggy Show. May 13, 2017 (tentatively) will be the Spring Fling Schooling Show.

Awards: Jones' are donating a new Third Level trophy.

Laureen and Jennifer will be collaborating on a ribbon clean-up pizza party with the 4-H dressage group and NDA Juniors.

Publicity: The Contact: The next Contact will be the September/October issue. Western Dressage: Last month, the Committee spoke via email, Sheila Purdum asked if the NDA would consider the WDAA scores at the World Show to be considered at Year End Awards. Yes, she can because it is USEF recognized. It would just apply as WDAA High Point Award.

The wording on #13 page 8 will need to be clarified. The Western Dressage Committee will decide on the wording for 2017, and run it by the Board. The NDA High Score award is for classical dressage, the WD award is for High Score WD, as suggested by Melissa.
