### Call to Order

# **Approval of Previous Meeting Minutes**

The February 2016 NDA meeting minutes were reviewed. Jane moved to approve the minutes. Judy seconded. Motion carried. Minutes approved.

### **Officer Reports**

**Vice President:** Jane Fucinaro provided the Vice President's report. The NDA Banquet and Awards presentation will be November 19 at the Ashland Country Club. Jane asked that the board help decide on menu options. RSVP date will be earlier than last year.

**Secretary:** No report.

**Treasurer:** Melissa Ward provided the Treasurer's report on behalf of Kathy Hanford. There will be upcoming expenditures for the Pilates for the Dressage Rider Clinic.

## **Committee Reports**

### **New Business**

NDA wishes to foster Western Dressage education. Discussion ensued as to the possibility of holding a dressage foundation clinic that would be geared for both western and English. Further, the possibility of establishing a Western Dressage NDA Committee was discussed.
