#### **Competitions:**

Regarding Schooling Show Championships, Jennifer stated that they continue to receive many incomplete entries. There was discussion of how we might make this process easier for both competitors and show management.

Judges are in place for the 2019 Cornhusker Classic and Jennifer is now looking for judges for 2020.

Jennifer received word that the Shaggy Show for 2019 has been cancelled.

Jennifer also reported that the Omaha Equestrian Foundation is considering changing its format and qualification requirements for its dressage competition at The International. No firm decisions at this time.

#### Awards:

NDA-sponsored 4-H high point awards (for traditional and western dressage) will be presented October 4 at the Lancaster County Horse Awards Night.

Ribbons and gift cards for Schooling Show Championships are ready to go.

Sheila Purdum has ordered trophies for the memorial awards that she is sponsoring.

The board has received a request to add an FEI Childrens Award for the 2018 competition year. The board decided not to add the award for 2018 because it had not been included in the

year-end awards listed in the member handbook. However, a proposal can be submitted to add the award to the 2019 year-end awards.

The board agreed that FEI Childrens Test scores can count towards Second Level year-end awards this year.

# **Publicity:**

Kayla reported that the Show Issue of the newsletter will be published in late September and will include Schooling Show Championships results. The quarterly newsletter will be sent out in late October.

Jane stated that Melissa Ward had sent a reminder about the board's social media policy. NDA Facebook posts should be restricted to discuss/advertise only NDA-sponsored events. Melissa will talk about the policy in more detail at a future meeting.
