### NDA TRAINER TIP

### This month's Trainer: Felice Rose

I have found that downward transitions are most difficult for many riders. They often lose the rhythm and cadance of the new gait.

Start your transition by making certain that you are centered. Just give it a seconed or two to think about it. Begin with some light half-halts, preferably with the outside rein. Use leg and seat aids to improve engagement...think of riding up a small hill. Use very light rein aids. More like a give and take fixed hand. Ride forward into the downward transition maintaining rhythm and tempo of that gait. Think of your own balance and certering with the new movement.

Lisa moved to approve the August Board Meeting Minutes with one correction; Diana seconded. Motion carried.

#### **REPORTS OF OFFICERS:**

*President:* Gillian announced that Nancy Dostal has resigned from the Board due to conflicts with her work schedule. We want to thank her for her participation on the Board and we accept her resignation. Gillian announced that she has also met with a representative of the Dressage Foundation and discussed NDA's interest in working more closely with them in the upcoming months.

#### Vice President: No report

*Treasurer:* Diana presented the Treasurer's Report as of September 20, 2010. The balance in the Main Account was reported to be \$11,277.46. The balance in the Show Account was reported to be \$4,705.39. Total amount was \$15,982.85. Amy moved to approve the Treasurer's Report; Casey seconded. Motion carried. Diana noted that we need to add another official representative to our main checking account. She is the only approved member who can sign at this time.

#### Secretary: No report

#### **REPORTS OF COMMITTEES:**

*Membership:* There were no new members this past month. Karen is gearing up for the 2011 membership campaign. The new membership form will go out in either a blast e-mail or by snail mail (courtesy of Stricklett and Associates) toward the end of October. There will be a deadline of November 12th for renewals as the updated roster is due in the USDF office by no later than 11/30/10. Karen has asked that a membership "renewal" table be made available at the Banquet. Lisa presented the Proposed 2010 Budget analysis and her summary of expenses and income for 2009 (spending history). Lisa also prepared a flow chart of Board positions, officer positions and committee groupings for review. Lisa and Karen agreed to serve on the "nominating committee" for the upcoming banquet and will be calling members to solicit more active participation in NDA. Based upon a review of the Budget, the proposed increase in dues for 2011 was presented to the Board: Individual - \$40; Junior Individual/Pony Club/4-H - \$30; Family - \$60 with each additional (besides P and S)- \$20. Membership fees will include online subscription to the newsletter. If member wishes to receive newsletter via mail, a subscription fee of \$15 will be charged. Announcement regarding 2011 dues increase will be posted on line and published the Contact. Lisa moved to approve the dues increase as noted; Casey seconded the motion. Motion carried.

*Competitions:* Gillian reported on behalf of this committee. Due to Tracie Wang's resignation, a replacement is needed. Mike Smith has agreed to serve as Manager of the Cornhusker Classis I and II in 2011; Amy Blum has agreed to serve as Assistant Manager. Gillian has also agreed to continue to serve on the Competitions Committee for 2011. The need for a volunteer coordinator was discussed. Lisa and Karen agreed to assist in bringing more members into committee positions; it was suggested that a Board member serve on each committee but not "be" the committee.

*Awards:* As noted in the prior minutes, Julie Hutfless Fowler will be handling awards at the Banquet again this year. This will be her last year, however, so a replacement for 2011 will be needed. Trophy options for the Lowell Boomer Jr/YR High Point Trophy that will be awarded at the Cornhusker Classic were shared. This would be awarded to an NDA member for any test (Training Level through Grand Prix) on any day of Classic Show. Gillian is also considering donating an Adult Amateur Vintage Award on behalf of her partner, Maple. This trophy will be a year end award for 2011. Details to follow.

Communications: No report.

Publicity: No report

*Fund Raising:* Heidi Helmer will be soliciting donations for the Annual Banquet Silent Auction. She has agreed to serve in this capacity for this year's banquet once again. Thank you Heidi!

#### Equipment Management: No report.

*JR/YR:* Casey has several ideas for Junior Young Riders this coming year. She is currently soliciting ideas for articles about other Juniors to be published in the Contact. 
#### OLD BUSINESS: None

#### Convention Article cont'd

The Grand Ballroom was the place to be for the Annual Awards Banquet. It was beautifully decorated. Each table had a top hat with a vase of flowers on top of the hat. The awards process is fine tuned. There were big screens on both sides of the stage. As the banquet progressed, the big screens would provide which awards would be given next, queuing the recipients to line up behind the stage. It worked flawlessly. We had a fabulous meal while we listened to the award presentations.

The program started out with George Williams awarding the Volunteer of the Year Awards as well as the Lifetime Achievement Awards. Then came the Rider Awards. The entire Bronze, Silver and Gold medalist, as well as the Freestyle Bar recipients lined up and received their honors. I was surprised how many riders had earned multiple medals. Next came the Perpetual Trophies which included Ravel as the Grand Prix Horse of the Year. There was an outstanding video with all the exciting moments Steffen Peters and Ravel had over the past year. Akiko Yamazaki who owns Ravel accepted the award and gave a wonderful speech about the accomplishments over the past year and thanked all the members of "Team Ravel", which is quite the entourage!

Next up was the Breeder Awards, Horse of the Year Awards for each level, the Dover Saddlery Medal Program, Vintage Cup, Junior/Young Rider Awards by level, Adult Amateur by level, FEI Five and Six Year Old Awards, and Musical Freestyle Awards by level. Dallas placed 3rd overall at the JR/YR Training Level, but only 1st and 2nd place winners are given their awards at the banquet.

The last half of the banquet was the All-Breeds Awards. At this point, USDF Executive Director Stephan Hienzsch took over the handing out of awards. I had no idea there were so many breeds. Some of the less obvious ones were the American Mule Association, American Mustang & Burro Association, Curly Sporthorse International, Nokota Horse Conservancy, Inc, and Gypsy Horse Association, Inc. Then we got to the Friesians! Here is a rundown: Friesian Heritage Horse and Sport Horse International, Friesian Horse Association of North America, Friesian Horse Society, Inc, Friesian Sporthorse Association, and Friesian Sporthorse Registry. Who knew there were so many for Friesians! Biggest lesson learned during the banquet--there are actually 62 different breed registries that are recognized by USDF! Finally, we reached the KWPN of North America awards, which is the Dutch Warmblood registry. Dallas received a 1st place medal in the Junior/Young Rider Training Level division! It was very exciting!! After a long day of travel and a very long banquet, we had no problem getting to sleep that night.

The next day we did a little shopping then headed to the beach. Dallas is 15 years old after all, and if there is an ocean nearby, she has to stick her feet in it. Jacksonville has some beautiful beaches and ocean front properties. We saw three people on horseback trotting up and down the beach.

We then headed to the Jacksonville Equestrian Center to catch some of the Dressage on the First Coast show which was being held in conjunction with the USDF Symposium. This is also the facility where the new 2011 dressage tests were being debuted during the Symposium. It was a wonderful facility that would seat up to 3,700 in the indoor arena and large 12 x 12 open air stalls outside. who were on site for the day. We checked out all the horses and admired all the nicely decorated stalls with Christmas décor. There were even Christmas songs playing throughout the barn. We loved looking over all the Poulin Dressage horses. We did not get to see Michael Poulin ride, but did get to see Katherine Poulin compete in the FEI Musical Freestyle Challenge TOC. All of the Freestyles were magnificent. Most of them were performed to Christmas music which made it extra entertaining. Biggest lesson learned during the show-they get prize money!! The riders earn prize money for their classes. The USDF Musical Freestyle Challenge TOC winner was awarded \$500 and the FEI Musical Freestyle Challenge TOC winner was awarded \$1000! 2nd and 3rd place winners received smaller amounts. Coming from Nebraska, we had no idea this was taking place. The last rider of the night went about 7:10 PM, so by the time the show was completed it was getting late and we had an early flight out the next day. We were sad to see the end our trip come so soon.

The flights down and back were uneventful, which is a blessing when you are only going to be gone two and a half days. We had great weather with beautiful clear skies. We met some great people at the banquet and got to see some awesome freestyle rides at the show. If you have the opportunity to attend the convention or banquet I highly recommend it. The annual convention is held to conduct business of the federation and provides networking opportunities and education sessions built for dressage professionals and enthusiasts of all levels. I can't wait to find out where it will be held next year.
