Entries:

Only online entries accepted – No mailed entries

- * One entry per horse/rider combination per show number
- * Enter at <http://horseshowoffice.com/>
- * All documentation must be submitted by closing date (May 8, 2026)

Required with entry:

- * Coggins (last 12 months & must list USEF recorded name - no barn names)
- * Health certificate (30 Days) and proof of vaccinations within previous 6 months per USEF rule GR 845
- * All required Membership numbers must be provided for Rider/Trainer/Coach/Horse with entry.
- * Electronic payment by e-check or PayPal

Administrative Fees:

Office Fee: \$40/show
Late fee: \$50/rider

Stabling & Fees:

One day/night Horse Stall: \$50 day/night
Tack Stall: \$50 day/night
Double Stall: \$100 day/night
Post Entries (as sched permits): \$25 added to class fee
Bedding (\$25 fee for outside): \$12/bag*

Important: Each day is a separate show. Use current entry form. Competitors showing both days must complete two separate entry forms and pay two separate office fees and USEF Horse/Drug fees. Stabling fees need only be paid once. Entries taken based on the order in which they are received and may close early if shows are full. Remaining entries received will be placed on a wait list based on entry time stamp.

Great American/USDF Qualifying Classes: Qualifying will not require a separate ride. An additional \$20 USDF Qualifying fee, in addition to the class fee, will be charged.

Equipment Checks – The Technical Delegate may check equipment at any time and in any place starting the day before the event and continuing through the show dates. You do not have to have your bridle checked before you school.

Freestyle Sound Checks – Will be held on Friday evening (subject to change, check show office). It is preferred that music files (MP3) be sent to the announcer by Wednesday, May 13, 2026. Music can be provided in WAV or AIFF format on a CD (USEF DR129); however, if you choose to bring a CD we encourage you to bring additional backup formats (ie MP3).

Stalls: Temporary indoor 10x10 stalls with doors. Rubber mats available for rent. All horse stalls will be on dirt. If you need specific accommodations for a stallion, please contact the show secretary. If you bring in outside bedding, you will be assessed a \$25 cleaning fee per stall.

Medical Waste: Sharps containers are located in the barn area. Per USEF rules, competition management may fine any individuals, including trainers, owners, exhibitors, and their agents, up to \$100 for improper disposal of needles or other sharp disposable instruments.

Post Entries: Will be taken as scheduling permits, with \$25 added to the fee per class. Any horse/rider changes after an entry is submitted will incur a fee of \$25. **All other changes made after the closing date will incur a charge of \$10/change.** The Show Office must be notified by 3:00 pm the day prior to the requested ride change.

Refunds: Office fee is not refundable. **Entries with written cancellation on or before the closing date will receive 100% refund less the office fee. No refunds after the closing date.**

Awards: Ribbons awarded through 6th place in every class for each division, including Novice and 55+. Champion and Reserve Champion ribbons awarded for the highest scores at each level on Saturday only (minimum score of 60%). Three High Point trophies will be awarded to the NDA junior, NDA AA member and NDA Open rider with the highest score (Training-Grand Prix) from either show. A minimum score of 60% required for High Point Awards. **Breed awards are available and will be posted in the show office.**

Opportunity Classes: Horses and/or riders entered in Opportunity Classes can cross enter into rated/recognized classes in the same show. If cross entered, all applicable fees and membership requirements apply. There are no USEF or USDF membership requirements for horse/rider and no drug fees to participate in Opportunity classes.

Confirmation/Times: Confirmation of entry will be emailed. Ride times will be posted at www.horseshowoffice.com.

Ride Times: Tentative ride times will be posted at www.horseshowoffice.com. Official ride times will be posted in the show office by noon the day before the show. It is the responsibility of the rider to inform show management of any time conflicts as soon as possible after receiving ride times.

Arenas: All arenas are GGT outdoor all-weather footing. Introductory classes may be ridden in a small arena (20m x 40m). Training tests 1 and 2 may be in a small arena. All other classes will be in a standard arena (20m x 60m). Lunging area will be separate from warm up arenas.

Other Items:

Bridle Tags: Numbers must be worn **at all times** when a horse is being exercised or ridden. Failure to do so shall be cause for elimination. **No Shows:** All “No Shows” that have not contacted the show office prior to first ride will be considered a scratch for the rest of the show and time slots may be filled.

Concessions: Available on the grounds one hour before start of show until the end of the show.

Dogs: Dogs must be leashed and attached to a person at all times. Management may assess a fine if leash rule is not complied with.

Important National Class Information:

Amateur Division (AA)

Individuals possessing current amateur certification are only eligible as Adult Amateurs from the beginning of the calendar year in which they reach age 22. Only active United States Equestrian Federation members may obtain amateur status. (Exception: Equine Canada members in possession of current EC membership may sign for USEF Amateur status on a show by show basis at no cost). Participants must possess current USEF Amateur status and qualify under the USEF Amateur rules. If opportunity classes at Dressage Competitions are restricted to amateurs, riders are required to have an amateur status with USEF.

The Junior/Young Rider Division (JR/YR)

Riders are eligible to compete in these classes until the end of the calendar year in which they reach the age of 21.

Pony Classes

Pony Classes offered are listed on the Prize List. The pony division is open to all breeds that meet the following measurement requirements. In the Dressage Division, a pony is an animal that does not exceed 148 cm (14.23 hh) without shoes, and 149 cm (14.27 hh) with shoes. The pony can be of any sex (Mare, Stallion, or Gelding).

- Ponies under the age of eight and in possession of a valid temporary card from another division or discipline should submit a copy with their entry.
- Measurement will be required for these pony specific classes if they do not currently have a valid measurement card. Measurement will be yearly beginning from the age of three (36 months) until the pony has reached the age of eight years. Animals three through seven years old will be issued an annual Temporary Certificate of Measurement and must be re-measured annually until the age of eight years. Animals eight years and older will be issued Standard Certificates of Measurement which will not need to be renewed. Measurement must be done on USEF Combined Driving and Dressage Pony Measurement form. Individual responsible for presenting the pony for measurement must be 18 years old. Animals submitted for measurement or re-measurement must show no evidence of lameness and must be jogged for soundness prior to the measurement. Animals showing evidence of lameness are not eligible for measurement or re-measurement.
- The pony must be entered to compete at the competition for a measurement to take place.
- When the competition veterinarian is on call and an alternative measurement time is necessary, management must receive a written request for measurement from the owner or agent at least five days prior to the start of competition to set up a time.
- It will be the pony owner's responsibility for the fee charged by the veterinarian. The fee cannot exceed \$150.00 and will be payable to the veterinarian. The measurement must be done prior to first ride.
- Request for a pony measurement must be made to the show secretary (gandasushko@hotmail.com) by Friday, May 8, 2026.

The Cornhusker Classic Scramble

- After a fun, successful inaugural year in 2025, The Cornhusker Classic Scramble team competition is back and FREE in 2026! You may create your own 3-4 person team or you will be assigned to one if you do not sign up as a team with your entry. This team competition is open to USEF Junior/Young Riders and Adult Amateurs (with amateur card) and non-members in Opportunity classes (no card required). Open (professional) riders are not included in the Scramble but can create their own teams for informal bragging rights. Each horse/rider combination may only be included on one team. No horse or rider substitutions after the show begins.
- Teams will consist of 3 or 4 entries with the 3 riders' highest scores (Saturday rides only, HC rides excluded) to be included in the team average (i.e. 1 score will be dropped for 4-person teams). Any combination of levels (Intro-Fourth only) and tests in those levels is allowed but you are expected to show at the same level you compete in at other competitions. The team with the highest average will be awarded gold medals, the second highest average will receive silver medals, and the third highest will receive bronze medals. In case of a tie, the highest single score will determine the winning team.
- The awards presentation will be Saturday evening on the showgrounds. At least one representative from each team is required to attend the awards ceremony (riders only, horses get to rest in their stalls). Please RSVP on your entry form as Yes/No/Maybe to help NDA plan for food. Guests are welcome and encouraged to come.
- The goal of the Scramble is to encourage friendly competition and build camaraderie among fellow dressage enthusiasts. You will have access to your teammates' cell numbers so you can decide on a team name, theme or colors, meeting place, secret handshake, victory dance, etc. Stall charts and ride times will also be available, as usual. The

show will be even more fun for everyone if you find time to leave encouraging notes on stall doors, send a good luck text, cheer on your teammates at the show ring, and generally show off your excellent sportsmanship!

Classes per Day

Horses are limited to a maximum of three Dressage rides per day at Fourth Level and below or two Dressage rides per day above Fourth Level. Horses competing at both Fourth Level and Prix St. Georges, or their equivalents, are limited to two Dressage rides per day. Dressage Seat Equitation, Quadrille, Pas de Deux and Materiale classes are excluded from the maximum limit of rides per day and horses in these classes may compete at any level for which they are otherwise eligible during the same competition.

Consecutive Levels

Horses may enter no more than two consecutive levels, Freestyle levels included, at any one competition.

Current Rules

The rules may have changed from the current USEF Rule Book. It is the competitor's responsibility to check the current USEF Rule Book for any changes. Current rules can be found on www.usef.org.

Para-Equestrian

Competitors and their horses are no longer exempt from USDF memberships. Para-Equestrian competitors will now be required to have a USDF participating membership or a USDF group membership or a Non-Member fee will apply. All horses will need a life or HID USDF membership.

US Equestrian Federation General Rules and Regulations

Show Management reserves the right to vary or add officials and refuse any entry for a cause; to disqualify any exhibitor and/or his or her horse for cause; to cause an exhibitor to forfeit his or her ribbons and winnings for cause; to return any entry and/or stall fee before or during the show for cause; all without being liable for damage or compensation. Show management reserves the right to make any changes deemed necessary for the safe and efficient conduct of this competition.

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds. Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

Weather/Acts of God/Accidents or Emergency Policy:

Management reserves the right to cancel any classes due to hazardous weather, Acts of God, Accidents or Emergencies. Every effort will be made to re-schedule with priority given to CDI or USEF Program classes. No refunds for cancellations due to hazardous weather, Acts of God, Accidents or Emergencies.

Membership/Registration Requirements:

Riders/Owners/Trainers/Coaches must be current USEF members. Riders/Owners must also be a member of the USDF (participating for GAIG/USDF qualifying) or a \$55 Non-Member fee will apply. USEF Show Pass (Non-member) Fee of \$45 must be payed on USEF website, if eligible. Horses must have at least both a USEF (free) and a USDF HID number (\$45) to show in classes other than Opportunity. For GAIG/USDF qualifying the horse needs a USEF life or annual membership and a USDF life membership. Horses with only an HID are not eligible.

Show Conflict/Rider Time Conflicts:

Changes need to be requested in the show office by 3 pm the day prior to the start of the weekend (Friday, May 15, 2026)..

Protective Headgear: USEF Rule GR801 applies.

SAFE SPORT STATEMENT: Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition. All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. 5. Merge onto I-29 S.

Regional Adult Amateur Equitation Program

The USDF Regional Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. An Adult Amateur Equitation Regional Final class presented by Big Dee's Tack and Vet Supply will be held in conjunction with each of the nine USDF Regional Dressage Championship competitions, providing adult amateurs with additional opportunity for recognition. Ribbons awarded through 8th Place and gift certificates awarded to top four riders

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

Qualifying Requirements

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

- a) Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDF-recognized Dressage competition within the qualifying period of the applicable regional championship.

or

- b) Qualified to compete in any regional dressage championship class (excluding freestyles).

Membership Requirements

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

2026 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at www.usdf.org. Please refer to the 2026 USDF Member Guide for the comprehensive list of rules and requirements for this program.

Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

Rider:

- Must have a USDF Participating* Membership (PM).
- Must have a USEF membership (Active or Life).

Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse Recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s).
A horse is not required to have breed registry papers.
- Horses must be entered in qualifying and championship classes under their official recorded names and ownership as specified in USEF GR1102.3, and transfers of ownership or lease registrations must be completed in compliance with USEF rules GR1105 and GR1108 prior to the competition in order for the horse to compete under the name of the new owner or lessee. (USEF DR127.2)

Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Active or Life Membership or Annual Recorded Farm/Business (with Senior Active Competing Farm Owner in good standing)). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.

* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

Minimum Qualifying Scores: One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider.

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and

(**"USEF Event"** or **"USEF Events"**); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the **"Agreement"**):

A. **RULES AND REGULATIONS:** I hereby agree that I have read, understand, and agree to be bound by all applicable Federation Bylaws, rules, and policies including the USEF Safe Sport Policy and Minor Athlete Abuse Prevention Policies (MAAPP) as published at www.usef.org, as amended from time to time.

B. **ACKNOWLEDGMENT OF INHERENT RISKS:** I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with equine activities, including but not limited to horseback riding and equestrian sport, are inherently dangerous, and that participation in any USEF Event involves risks and dangers including, without limitation, the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; contact or collision with other participants and horses, natural or manmade objects; adverse weather conditions; facilities issues and premises conditions; failure of protective equipment (including helmets); inadequate safety measures; participants of varying skill levels; situations beyond the immediate control of the USEF Event organizers and competition management; and other undefined, not readily foreseeable and presently unknown risks and dangers (**"Risks"**).

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$100), 5-years (\$400), or life (\$2,000). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$80). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$280) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$55 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$45). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$95. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$140) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

How to Join USDF

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

- On the USDF website: www.usdf.org. You can submit the application online or download the form.
- In the show office at USEF-licensed/USDF-recognized competitions classified by USEF as Dressage Competitions, and Regular Competitions which are open to all breeds.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same day.
