

USEF RULE CHANGE - HELMETS

The US Equestrian Federation has implemented a rule change (DR120) regarding protective headgear. Effective Martch 1, 2011, helmets are required at USEF/USDF shows for:

- all riders at Fourth Level and below
- all riders 18 and under, regardless of level
- all para-equestrians
- all in FEI Pony, Junior, and 4, 5, & 6-year-old tests, plus USEF 4-year-old.




