Post Entries (as schedule permits) \$25 added to class fee

Refunds: Office fee is not refundable. Entries with written cancellation on or before the closing date will receive 100% refund less the office fee. No refunds after the closing date unless the show is canceled.

Ride Times: Ride times will be posted at www.nebraskadressage.org and emailed to riders. Owners and trainers wishing ride times must contact the rider of the horse. It is the responsibility of the rider to inform show management of any time conflicts within 24 hours after receiving ride times.

Awards: Ribbons awarded through 6th place. Additional prizes may also be awarded.

Arena: All Introductory, In Hand tests 1 and 2, Training and Basic tests 1 and 2 may be ridden in a small arena (20m x 40m). Sport horse and handler classes will be set up in the warmup arena. All other classes will be in a standard arena (20m x 60m). Note that there is no warmup arena. There is both a sand and a grassy area that can be used. Riders will be allowed to ride in the arena footing during breaks and over lunch **but only outside the show ring.**

Weather/Acts of God: Management reserves the right to cancel any classes due to hazardous weather, Acts of God, Accidents or Emergency. Refunds of 100% of canceled classes only less the office fee for cancellations due to hazardous weather, Acts of God, Accidents or Emergencies. **No rain date.**

Other: <u>Concessions:</u> Available on the grounds, open during show hours. <u>Dogs:</u> Dogs must be leashed and attached to a person at all times. Management may assess a fine if leash rule is not complied with.

Attire: For classical dressage classes, refer to Nebraska Dressage Association's Recognized Schooling Show requirements: 1) Simple snaffle bridle mandatory through Second Level (except for Western Dressage classes); 2)

English-style saddle mandatory (except for Western Dressage classes); 3) Rider must wear boots or hard-soled shoes with heels; 4) Humane spurs and a whip no more than 4 feet long are allowed; 5) No tie-downs, martingales, side reins, or similar devices are allowed; 6) All Classical and Western Dressage Riders must wear ASTM/SEI-certified helmet at all times when mounted.

Class Sponsor: You can sponsor a class of your choice for \$10. Enter the class No. on the entry form (e.g. \$10 for sponsoring Second Level Test 1). Your sponsorship will be acknowledged at the show during your class of choice, as well as listed in the Contact Show Results edition. Sponsoring a class will give you a chance to cheer on your riders and help to cover the cost of the ribbons.
