<u>Fees</u>

Class fees: \$25 for dressage tests, \$15 for equitation.

**Stall fees:** \$15 for horse and/or tack stalls. If you need additional nights of stalling, please contact the show manager. Stalls must to be stripped prior to your departure.

**Shavings:** \$8 per bag. Shavings MUST be purchased from the Event Center. No outside shavings allowed or you will be fined.

Office fee: \$25 per horse/rider pair.

Camp sites are available for \$35 per night purchased through the General Store in Pavilion 2.

### This show is NDA Recognized.

One entry form per horse/rider combination. Entries due April 15, 2023.

Show hours will be 8 am to 5 pm. To maintain this schedule, entries may be limited.

Full payment is required before assignment of ride times.

Competitors (or parent/legal guardian) must sign a waiver prior to release of show packet.

Standard arena (20m x 60m) will be used for all tests except Intro, Basic, Training level 1 & 2.

NDA Recognized schooling show requirements apply (see www.nebraskadressage.org).

### HELMETS REQUIRED BY ALL RIDERS, NO EXCEPTIONS

Ribbons 1st-6th place by division. There will not be ribbons awarded for Test of Choice.

Horses may move into stalls after 4pm on Friday April 28, 2023.

Warm-up will be available at the outdoor arena adjacent to Pavilion 3 and the indoor warmup in Pavilion 2.

Jump-outs will be allowed. With other events planned at the facility, please park near the outdoor warm-up adjacent to P3. There is no charge to jump out.

Schooling in the arena will be allowed Friday after 4pm and until 30 minutes prior to the show beginning Saturday, to allow for the tractor to work the arena.

Equitation will not be split per division. Open to all riders.
